Notice on chartered flights to Nepal

This is to inform all the concerned that the Government of Nepal has decided to repatriate Nepali nationals who have been stranded in Malaysia because of the global pandemic of COVID-19. The first stage of the chartered flights have been scheduled for the following dates:

Dates of flights	Nepal Airlines	Himalaya Airlines
15 June 2020	A320	-
18 June 2020	-	A320
20 June 2020	A330	-
21 June 2020	-	A320

For the repatriation via chartered flights following procedures will be followed:

1. The Embassy has published the first priority list of passengers who can buy the tickets of the chartered flights. The list has been derived from the online registration form published by the Embassy via its facebook page and website on 5 June 2020. Those with their names on the list will have to directly contact the airlines companies.

2. The airline operators for the chartered flights have fixed the price of tickets for the Kuala Lumpur- Kathmandu route at USD 520. To buy the tickets, the passengers will have to contact the airlines or designated agency. The family members of those stranded in Malaysia can also buy the ticket from the offices of designated airlines in Nepal. The contact details of airlines in Malaysia are as follows:

3. COVID-19 test (PCR swab test or RDT) has been made mandatory by the the Government of Nepal for the passengers prior to the flight. The passengers will have to carry the physical copy of the test result. The test should not be older than 7 days from the date of the flight. Only those with negative result will be allowed to board the aircraft. Facial masks are also mandatory for the passengers. These tests can be done at any clinic or hospital in Malaysia which have been authorized by the relevant agency of Government of Malaysia.

4. All the flights will depart from Kuala Lumpur International Airport (KLIA) and the passengers are requested to reach the airport 4 hours prior to the departure time.

5. In case, if the occupancy in the flights is not sufficient or because of some unseen circumstances, the flights may get postponed.

This is also to iterate that those, persons according to the list, who are unable to manage tickets from the airline companies
